Objectives and Investment Policy


The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by companies from all over the world and selected through a process aimed at reducing risk by minimising volatility in the Fund.

It is actively managed and as such may invest in securities that are not included in the index which is MSCI World (NR)

Income are systematically reinvested.


